This verification must include information that indicates that your license is not the subject of a disciplinary proceeding. You will not qualify for this license if you have been or currently are the subject of disciplinary proceedings in any jurisdiction in which you hold a license to practice a profession regulated in Florida under chapter 456, Florida Statutes.
- **4. OFFICIAL ACTIVE DUTY MILITARY ORDERS:** A copy of military orders showing your spouse is assigned to an active duty station in Florida.
- 5. PROOF THAT YOU ARE ENTITLED TO FULL LICENSURE: You must submit the full licensure application for the profession in which you are seeking temporary licensure along with any supporting documentation required by that application. Documentation that is required for both applications, such as license verifications, are only required to be submitted once. Full licensure application fees are not required for temporary licensure.

By submitting fingerprints, you are authorizing the dissemination of any state and national criminal history record that may pertain to you to the Specified Agency or Agencies from which you are seeking approval to be employed, licensed, work under contract, or to serve as a volunteer, pursuant to the National Child Protection Act of 1993, as amended, and Section 943.0542, Florida Statutes.
